

Amendment to Rule 270-X-3.02 Replacement Certificate for Dental Hygienists.

SUBSTANCE OF PROPOSED ACTION:

In its present form, this Rule refers to a duplicate certificate as a replacement certificate and provides for a set fee. Code of Alabama (1975) §34-9-16 refers only to a duplicate license certificate fee and sets the amount of the fee. Accordingly, to clear up any confusion about the use of the term replacement certificate and to delete the redundancy of the Rule provided for a fee already set by Statute, the Board intends on amending this Rule by deleting any reference, either in its title or body of the Rule, the term “replacement certificate.”
