RULE NO. AND TITLE: 270-X-5.08 AUTHORIZED FEES
INTENDED ACTION: Repeal the above referenced rule.

SUBSTANCE OF PROPOSED ACTION: The Alabama Dental Practice Act was amended during the 2009 Regular Session of the Alabama Legislature. One amendment involved Code of Alabama 1975 §34-9-16 to allow the Board to establish and collect fees. This rule as currently drafted establishes a set fee, therefore, in order to comply with Code of Alabama 1975 §34-9-16 this rule is due to be repealed.

TIME, PLACE, MANNER OR PRESENTING VIEW:


