12:20 p.m.

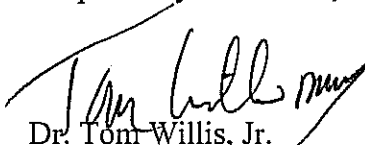

Minutes
BDEA Dental Hygiene State Board Exams
June 21- 22, 2010

The Board of Dental Examiners met on Monday morning June 21, 2010 at the Doubletree Hotel to conduct the written portion of the Hygiene State Board exam. The exam commenced at 8:00 A.M. and concluded at 11:30 A.M. The following Board members were in attendance for the exam: Renea Chapman R.D.H., Vice-President, Dr. Tom Willis, Jr., Secretary-Treasurer, Dr. Mike Mahan, Jr., Member, Dr. David Northcutt, Member, Dr. Bobby Wells, Member and Dr. Hunter Pope, Member.
